ORDER RESPECTING THE CITY OF PORTAGE LA PRAIRIE WATER AND WASTEWATER UTILITY REQUEST TO REVIEW AND VARY BOARD ORDER NO. 133/21

March 21, 2023

1.0 Executive Summary

By this Order, the Public Utilities Board (Board) grants approval of the City of Portage la Prairie's (City) request to review the rates previously set in Board Order No. 133/21 for the City's Water and Wastewater Utility (Utility).

The Board grants approval to the City for revised rates effective July 1, 2023, and the resulting increases to the rates approved January 1, 2024 and 2025.

The revised rates are below:

2.0 Background

This Board Order is best read in conjunction with Board Order No. 133/21.

In Board Order No. 133/21, issued December 13, 2021, the Board granted approval for revised water and wastewater rates effective July 1, 2022, April 1, 2023 and January 1, 2024 and 2025.

3.0 Board Methodology

Request to Review and Vary

Pursuant to the Board's Rules of Practice and Procedure, and in particular, Rules 36(1) and 40(2) thereof, the Board may on application or on its own initiative review, rescind, change, alter or vary any decision or Order it has made. The Board's jurisdiction in that regard flows from section 44(3) of *The Public Utilities Board Act* (the *Act*).

In accordance with Rule 36(4), upon receipt of an application for review and variance, the Board is to determine, with or without a hearing, in respect of an application for review, the preliminary question of whether the matter should be reviewed and whether there is reason to believe the order or decision should be rescinded, changed, altered or varied.

After determining the preliminary question under Rule 36(4), pursuant to Rule 36(5), the Board may:

- a) Dismiss the application for review if,
 - i. In the case where the applicant has alleged an error of law or jurisdiction or an error in fact, the Board is of the opinion that the applicant has not raised a substantial doubt as to the correctness of the Board's order or decision; or





- ii. In the case where the applicant has alleged new facts not available at the time of the Board's hearing that resulted in the order or decision sought to be reviewed or a change of circumstances, the Board is of the opinion that the applicant has not raised a reasonable possibility that the new facts of change in circumstances, could lead the Board to materially vary or rescind the Board's order or decision; or
- b) Grant the application; or
- c) Order that a hearing or proceeding be held.

4.0 Application

On February 16, 2023, the City submitted a request that the Board review its decision made in Board Order No. 133/21 and revise the water and wastewater rates approved. The City submitted it is in the process of participating in the construction of a large, new treated water reservoir that the City's Utility will be responsible for operating. This will incur significant new costs related to the net capital amortization and operation of the reservoir and the 2020 utility rate study and Board Order No. 133/21 did not include any provision for construction and operation of this reservoir. The City also submitted it has experienced significant increases in chemical costs in the last two years, having a material impact on the Utility's ability to meet funding targets established in the 2020 utility rate study. The City submitted this evidence as new facts not available at the time of the Board's consideration of the application resulting in Board Order No. 133/21. The City also provided a Council Resolution supporting the request to the Board.





5.0 Board Findings

The Board has reviewed the City's request and grants the request to review its decision on the grounds of new facts not available at the time of the Board's consideration of the application resulting in Board Order No. 133/21. The Board has determined it will decide this application by way of the paper based review.

The Board acknowledges the changes to the revenue requirements are such that the City was able to isolate and propose rate revisions without requiring a full rate application. The Board grants approval of the rate revisions as proposed by the City.

6.0 IT IS THEREFORE ORDERED THAT:

- The water and wastewater rates for the City of Portage la Prairie Portage la Prairie Water and Wastewater Utility, approved in Board Order No. 133/21 BE AND IS HEREBY VARIED effective July 1, 2023, January 1, 2024 and 2025.
- The City of Portage la Prairie prepare and distribute a Notice of Decision regarding the decisions found in this Order, published on or before May 31, 2023. A copy of the Notice and affidavit certifying publication must be submitted to the Board.
- 3. The City of Portage la Prairie amend its Utility rate By-law to reflect the decisions in this Order, and submit a copy to the Board once it has received third and final reading.

Board decisions may be appealed in accordance with the provisions of Section 58 of *The Public Utilities Board Act*, or reviewed in accordance with Section 36 of the Board's Rules of Practice and Procedure. The Board's Rules may be viewed on the Board's website at www.pubmanitoba.ca.

The Septic Truck Tipping fee shall be \$30.00 per load up to 14,000 litres.
